2. Application submittal does not guarantee acceptance to the contest. Space will be assigned in the order application and fees are received. The Entry Fee must accompany entry form for submittal. APPLICATIONS AND FEES MUST BE RECEIVED BEFORE APRIL 1, 2012. Entry fees are non-refundable if you are assigned a space.
3. There will be a MANDATORY cooks meeting on Saturday, April 21st at 10am.
4. NO pets are allowed.
5. Public tasting begins at 11am.
6. There are no utilities available on contest sites.
7. Quiet time is in effect from 11pm until 6am on Friday evening. Failure to comply may cause removal from contest site.
8. 5 lb. minimum Fire Extinguishers are required at your site.
9. No motorized golf carts or ATV's allowed except by event officials.
10. All cooks are required to provide a minimum of 7 gallons of chili for public sampling.
11. 10' X 20' spaces (1 space per team).
12. CASI CATEGORY: Governed by the CASI Rules. Complete Rules and Regulations may be viewed at [www.chili.org](http://www.chili.org).
13. OPEN CATEGORY- ANYTHING GOES: Can be made in advance of the contest or on site and can be made with no restrictions of meat, beans, or fillers.
14. SHOWMANSHIP CATEGORY: Dress up yourself and/or your booth. Judging will be made by a panel of Celebrity Judges.
15. PEOPLES CHOICE: Team who collects the most VOTES from the attendees.
16. No ancillary sales permitted without advanced approval.
17. Parking will be available in designated areas.
